4) BOARD ACTION ITEMS:

- a) Discuss potential options for office agreements with PCGID Board discussed. They decided there wasn't a problem with the agreement and to leave it as is.
- b) Review and discuss update to District Personnel Policy Board discussed. No changes are seen. We will bring a clean copy back next month for approval.
- c) Review and approve purchase of new Remote Tracker for water measurement The Manager presented an estimate to the board for a new remote tracker. 5) MANAGER'S REPORT:

- a) Update on water conditions The Manager presented the MBK flow projections. Things are looking good if we continue to get rain.
- b) Update on District employee The Manager reported that Tim is still out on disability. The District has about two weeks of work for an operator. We will get Mark to fill in until we figure out if Tim will be able to come back or not.
- c) Colusa and Glenn Counties groundwater meetings Gary Enos stated that he attended a Glenn County meeting yesterday. They discussed DWRs determination of the incomplete plan and are trying to work through the issues identified as the plan is due April 1st. They are also working on recharge with 215 water.
- d) PWRPA Meeting, Cap and Trade and P3 monies, power cost estimates There was a PWRPA meeting last week that Albert and Jered listened in on. They discussed litigation with PG&E and it looks like it will be a 10 year agreement. They are also going to start a finance committee to look into budgeting and finances a little more.

6) DISTRICT OPERATIONS:

- a) Pumping plant (Meter replacement, maintenance needs) The Manager reported that two meters have been taking out of the plant. One has been replaced and the Bureau is going to get us another one. Also, Al let us know that the transformers haven't been serviced in over 20 years. He is going to put together a proposal for that work.
- b) Current projects The guys are repairing trash racks and spraying. They are also working on the Road 57 project of lifting the pipe back up. We have reached out to receive a quote from a company to come out and check the meters out in the field to get things in compliance.
